

# **Program information & residency requirements**

- Possess a valid pharmacist license from the Pennsylvania State Board of Pharmacy
- Completion of PGY2 Oncology R1 goals & objectives with a status of achieved for residency and for >75% of remaining objectives having a status of achieved for residency
- Presentation of a medication use evaluation project at the ASHP Midyear Clinical Meeting and research project at Hematology/Oncology Pharmacy Association annual conference
- Completion of a manuscript for the research project
- Completion of four major presentations, one of which includes CME/CE programing
- Completion of institutional credentialing program for pharmacokinetics and anticoagulation
- Completion of staffing requirements for the oral chemotherapy & oncology infusion clinic

- PharmD or equivalent degree (from an ACPE-accredited school of college)
- Completion PGY1 pharmacy residency program with ASHP accreditation or candidate status
- Licensed or eligible for licensure in the Commonwealth of Pennsylvania
- Virtual interview
- Pharmacy Online Residency Application containing:
  - » Curriculum vitae
  - » Letter of intent outlining career aspirations
  - » Pharmacy school transcripts
  - » Three professional references
